BANCO BPM: Ratings

Milan - Verona, 24 January 2017 - Further to the merger between Banco Popolare and Banca Popolare di Milano, which became effective on 1 January 2017, Fitch Ratings has today withdrawn the ratings previously assigned individually to the two banks. At the same time, Fitch has also affirmed and then withdrawn the ratings previously assigned to the subsidiaries Banca Aletti and Banca Akros. Currently, Banco BPM is therefore covered by the rating agencies Moody's Investors Service and DBRS, which published their ratings of the new Banco BPM on 3rd and 5th January 2017, respectively.
